Recent K-12 science teaching experience. Successful experience working with preservice teachers. Successful experience teaching and/or supervising preservice teachers. Prior experiences with demonstrated excellence in effective teaching.

### Duties

Teach undergraduate and credential courses on a part-time basis. Required mode of instruction may include in-person, hybrid, online, and/or any combination thereof. Primary responsibility includes teaching science education courses in elementary or secondary school teacher preparation. May also become involved in working with student teachers as a university supervisor.
